- Absolutely no phone, email, fax, incomplete entries or entries not accompanied by complete entry fees will be accepted. Post-dated checks will invalidate entry.
- **Each dog must have a separate entry form per stake entered. NO EXCEPTIONS!!!**
- **All entries must be sent via the United States Post Office OR a commercial delivery service** – no entries will be accepted in person. No entry will be accepted that requires a signature in person to receive it – please make sure to waive any signature requirement.
- Funds must clear before the event. An entry, once drawn, is a binding contract between the entrant and the club.
- The number of dogs eligible to run will be limited to daylight hours.

Hay

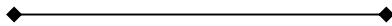
State certified weed-free hay for horses is available at Cowboy Up Hay & Feed, 928-333-4995, in Eager/Springerville just past the Dairy Queen.

Directions

From St. Hwy 260, just W. of Eager, AZ, turn S. on St. Hwy 261. Go approx. 10 mi. past Mexican Hay Lake. Turn Rt. (W.) on Forest Rd. 409. Follow signs to FT grounds @ Pool Knoll (approx. 8 mi.)

OR

Continue on St. Hwy 261 to Big Lake intersection. Turn Rt. On Forest Rd. 273 and go W. to Forest Rd. 409 on the Rt.



From St. Hwy 260 at the Sunrise Resort Billboard, turn Rt. (S.) onto St. Hwy 273. Follow St. Hwy 273 (partly dirt road) E. approx. 12 mi. just past the Gabaldon Camp Ground sign. Turn left on Forest Rd. 409. Go approx. 6 mi. to FT grounds @ Pool Knoll.

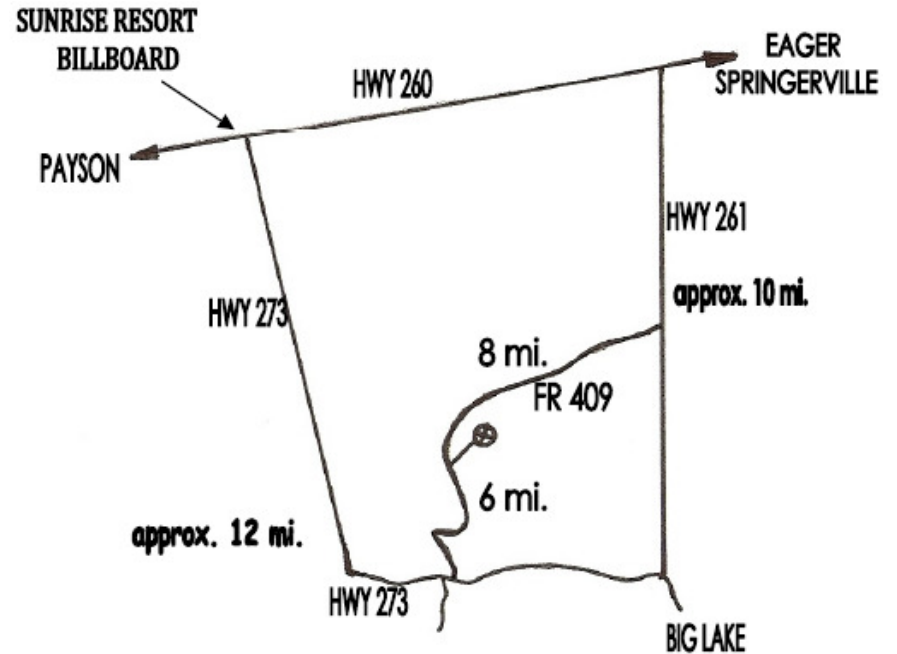
Courses and Birds

Amateur Gun Dog and Open Gun Dog are retrieving stakes, first bird will be liberated on course. All stakes are single course without a bird field. Quail and/or chukar released in all stakes except puppy stakes. Horseback handling will be permitted in any stake. Tracking collars permitted according to AKC guidelines.

Prizes

Standard AKC standard rosettes will be awarded for all placed dogs. First place winners in all stakes will receive plaques.

Open Limited Gun Dog is a money stake – 40% of entries in this stake will be paid out – 40% to 1st Place, 30% to 2nd Place, 20% to 3rd Place and 10% to 4th Place.
