Please note: Both the DGSPC and the NGSPA have had to pay significant cleanup fees and fines in past years due to campsites being left "as-is". The Forest Service is very strict at these grounds and expects all holes filled in, all trash picked up, all horse manure raked to less than ½ inch depth. Grass seed with weed-free grass hay needs to be spread over your stakeout circles and chain gang worn areas. The correct grass seed will be available from the trial committee. PLEASE PLEASE help us in making that happen before you leave. If we leave the ground in unsatisfactory condition, we risk losing access to these wonderful grounds.

OR

Continue on St. Hwy 261 to Big Lake intersection. Turn Rt. On Forest Rd. 273 and go W. to Forest Rd. 409 on the Rt.

From St. Hwy 260 at the Sunrise Resort Billboard, turn Rt. (S.) onto St. Hwy 273. Follow St. Hwy 273 (partly dirt road) E. approx. 12 mi. just past the Gabaldon Camp Ground sign. Turn left on Forest Rd. 409.

Go approx. 6 mi. to FT grounds @ Pool Knoll.

Amateur Gun Dog, Open Gun Dog, and Open All-Age are retrieving stakes. All stakes are single course without bird field. Quail and/or chukar released in all stakes except puppy stakes. Horseback handling is permitted in all stakes. Tracking collars permitted according to AKC guidelines.

Prizes

AKC standard rosettes will be given for all placed dogs. First place winners in all stakes will receive plaques.

NGSPA win certificates for all eligible dogs.

The Open Limited Gun Dog stake is a money stake. 40% of the entry fees will be divided up according to the following prizes: 40% to the 1st place winner; 30% to the 2nd place winner; 20% to the 3rd place winner; 10% to the 4th place winner.
